- 2. I DEVILLE my house and land at Bellerive to my Trustees in trust for my three step-daughters Emma Elizabeth Campbell Alicia
 Maria New and Mary Ann Louisa Robinson in equal shares as tenants in common and if any of them shall predecease me then her share shall go to her child or children who shall attain the age of Twentyone years and if more than one equally between them And I AUTHORISE and EMPOWER my Trustees at any time within Twentyone years after my decease on the written request of any beneficiary to sell the said house and land and convey the same to the purchaser thereof and to give a receipt for the purchase-money the net amount whereof shall in that case be divided between my said three step-daughters or their respective --- children in accordance with the trusts hereinbefore declared.
- 3. I DIRECT my Trustees to hand over all my household furniture and other the contents of my dwelling-house to my three Nieces Mary Louisa May Esther Ann Robey and Edith Consuelo Blyth or the -- survivors or survivor of them to be disposed of in accordance with my wishes which are known to them.
